Abstracts

- Mentzin Iu. L. The Mint and the Universe (Scientists at the Origins of the English Economic Wonder). Historians of science often portarayed Newton's long service as the Master of the Royal Mint as primarily an administrative work, hardly paying any attention to its financial-economic aspects. However, as this article attempts to show, analysis of the latter allows one to assess adequately his role in the making of a new type of financial system, the one that helped lay the foundations of England's economic power. The article pays particular attention to the 1695-7 financial reform, which Newton helped bring forth, and which became the precursor of English 18th-centruy "financial revolution."
- Kojevnikov A. B. Games of Stalinist Democracy: An Attempt of Interpretation of Ideological Discussions in Soviet Science of the Late 1940s. Stalinist political culture developed a system of ritualistic competitive games termed "intraparty democracy"— that allowed for grass-roots criticism and open-ended conceptual disagreements to exist and to be dealt with in a non-democratic environment. When transferred into the academic culture and applied to settle conflicts there, they produced unpredictable results. Access to documents from the party archives allows insights into the mechanisms of Stalinist decision-making. The comparative analysis of events in biology, linguistics, physics, and philosophy suggests a reconsideration of some accepted views on Lysenkoism and a new model of the relationship between science, ideology, and political culture.
- Kuznetsova N. I. "Atomic Trace" in VIET. The article tells the story of the editors' involvement in the events of 1992-1994, following the publication of sensational documents from the KGB archives (VIET. 1992. No. 3). At the order of a deputy prime-minister of Russian Federation, V. F. Shumeiko, the printing of the issue had been arrested, and the editors had to struggle for two years to rescue it and make the forbidden materials available to the readers. Those materials focused on "atomic espionage" by the USSR intelligence service in 1941-6, and highlighted the importance of secret information obtained from London and Los Alamos for the making of the first Soviet atomic bomb. Although the archival documents submitted to the journal (including drafts of the US atomic bomb of 1945 and its description) had already been declassified, some experts thought that technical information contained in them was so detailed that they could be put to practical use (e. g., by terrorists). They came to conclude that their publication would be socially dangerous. In that story scientists, journalists, and state security officials encountered the issues of legal and ethical responsibility that have no clear and easy solutions. Hence, it prompts one to ponder over the consequences of decisionmaking in the developing democratic society, involving the citizen's free access to information, on the one hand, and the social risk of published data, on the other.
